## **SWIFT Sport Springs & Stabilizers 3 Year Limited Warranty for On-Road Use Only**

### **SWIFT's Three Year Limited Warranty**

SWIFT Springs ("SWIFT") warrants all SWIFT Sport Springs & SWIFT Stabilizers ("Product") under a Limited 3 Year warranty starting from the date you purchased the Product. The rubber bushings for the stabilizer are covered by a Limited 1 Year warranty starting from the date you purchased the Product. The warranty covers the Product against factory defects in material and manufacturing (cosmetic defects, rust and finish imperfections are not covered) when correctly used on the recommended passenger car the Products are designed for and used under normal operating conditions.

This Warranty is only extended to the original purchaser who retains ownership of the vehicle on which the Product was originally installed.

### **Warranty Coverage**

SWIFT, after verification of warranty coverage, will at its discretion replace the defective or prematurely worn-out Product without charge.

The foregoing limited warranty is applicable only to new Products sold within the United States and constitutes SWIFT's sole warranty and that of its affiliated companies respecting the Products.

If purchaser desires to assert a claim or file any legal action for breach of warranty or upon any other basis arising out of or related to this limited warranty the products or services provided by or on behalf of SWIFT or its affiliated companies, the action must be commenced no later than one (1) year after the accrual of the cause of action.

Neither SWIFT nor its affiliated companies shall be liable for any damage injuries or death caused directly or indirectly by any products based upon warranty contract strict liability tort (including negligence) or other claims. This limitation or remedies shall survive even if the remedy is claimed to be the failed of its essential purpose.

### **Exclusions from warranty**

THIS WARRANTY SHALL NOT APPLY TO ANY PRODUCT WHICH HAS NOT BEEN PROPERLY INSTALLED BY A QUALIFIED LICENSED MECHANIC WHO IS EXPERIENCED IN THE INSTALLATION AND REMOVAL OF SUSPENSION SPRINGS, ANY PRODUCT WHICH HAS BEEN SERVICED IMPROPERLY, ANY PRODUCT THAT HAS BEEN MISUSED, MODIFIED, ALTERED, ABUSED, PRODUCTS THAT HAVE BEEN SUBJECTED TO NEGLIGENCE, ACCIDENT OR COLLISION. IN ADDITION, THIS WARRANTY DOES NOT APPLY TO PRODUCTS THAT HAVE BEEN IMPROPERLY INSTALLED OR INSTALLED IN ANY NON-ORIGINAL PURCHASER, OR COMMERCIAL VEHICLE OR ON A VEHICLE FOR WHICH IT WAS NOT DESIGNED TO BE USED, ON VEHICLES WHICH HAVE BEEN MODIFIED; WHICH HAS CARRIED LOADS IN EXCESS OF AUTOMOBILE MANUFACTURER SUGGESTED WEIGHT LIMITS OR PRESENTED FOR WARRANTY COVERAGE AFTER BEING USED ON A VEHICLE OTHER THAN THE ONE ON WHICH IS WAS ORIGINALLY INSTALLED.

### **Warranty claim procedure**

To make a claim under this warranty, the original purchaser must contact the SWIFT dealer/distributor that the Product was originally purchased from. The dealer/distributor will apply for a Return Merchandise Authorization (RMA) number from SWIFT (please see our website for RMA procedures), and return the Product in question to SWIFT. Once the Product is received by SWIFT it will be evaluated. The original purchaser is responsible for packaging, and shipping costs of returning the Product in question to SWIFT, as well as all costs incurred for removing and installing the Product in the vehicle. SWIFT does not warranty labor costs. If the Product is covered by SWIFT's warranty, SWIFT will pay for the return transportation costs and will return the Product to the sender. If the Product is not covered by SWIFT's warranty, the Product will be returned freight collect to the sender. Products sent freight collect will be refused even if accompanied by a valid RMA.

All returns must be accompanied by a valid RMA number and a dated sales receipt evidencing the purchase of the Product. Returns must also contain a statement containing the original purchaser's name, address, make and model of the vehicle, a brief description of the suspected defect, and a detailed account of the circumstances under which the defect occurred.
